

September 2025 to July 2026 Spul’u’kwuks Clubhouse Fee Schedule

FULL-TIME RATES:

- **\$546.00** per month for school age full-time care (September/October/November/January/February/March/May/June/July)
- **\$31.00** per day for days school is in session in December 2025 (**5 days**)
- **\$31.00** per day for days school is in session in April 2026 (**2 days**)

Monthly fee includes:

- ❖ Early Dismissals
- ❖ Professional Days

Monthly fee does not include:

- ❖ Winter Vacation 2025
- ❖ Spring Vacation 2026

Morning ONLY RATES:

\$304.00 per month for AM care only (7:00am to 8:45am only)

- **\$26.00** per morning for days school is in session in December 2025 (**5 days**)
- **\$26.00** per morning for days school is in session in April 2026 (**4 days**)

The monthly fee does not include:

- ❖ Early Dismissals
- ❖ Professional Days
- ❖ Winter Vacation 2025
- ❖ Spring Vacation 2026

Drop-in RATES (if available)

\$61.00 Professional Days

Withdrawal information:

- ❖ **ONE MONTH’S** written notice or **PAYMENT** in lieu of notice is required to withdraw your child from the centre. Notice must be received no later than the 1st of the prior month. Notice for September must be received no later than August 1st or the September fee will be processed.
- ❖ Vacancies which occur after April 1st, are difficult to fill. The fees for May/June will be required if written notice is received after April 1st.
- ❖ To secure a child’s space for the coming school year the June payment is required.

Payment information:

- ❖ Families will have the option of paying by pre-authorized debit or credit card.
- ❖ If a child is unable to attend the centre due to illness or holidays families are still responsible for the full payment of agreed fees for the month.
- ❖ Families with fees outstanding for 45 days or more will be asked to withdraw their child until their account is current.
- ❖ All declined payments (Visa/MasterCard/pre-authorized debit) are subject to a \$40.00 fee.
- ❖ The Affordable Child Care Benefit through the provincial government is available for low income families to meet the costs of child care. A parent or guardian who qualifies for the benefit pays the difference between the benefit amount and our fee. It is the parent's responsibility to apply for the Affordable Child Care Benefit. Parents are also responsible for keeping their benefit current and for the full fee if their benefit expires. TTK will not back-date Child Care Arrangement forms. Benefits received 3 months after attendance date will not be processed. TTK is not responsible for applying for the ACCB on behalf of families, checking the progress of pending applications, nor reminding families of lapsed ACCB benefits.
- ❖ Affordable Child Care Benefit (ACCB) will be submitted at the start of each month, based on your child’s actual attendance and will be credited to the following month’s payment. This means that monthly ACCB payments may vary, based on days in attendance. For example, the first week of October, your child’s September attendance will be submitted to the Affordable Child Care benefit and the amount received based on your child’s in-centre days will be credited to your October 31st payment. Any overages from your child’s first month of care will be either credited to breaks (Winter, Spring, and/or Summer) or refunded upon your child’s withdrawal.

Late Charges:

- ❖ Our centres close at 6:00 pm daily. Parents/Guardians picking up their child will be charged \$10.00 for every 15-minute block after 6:00 pm. The late fee is not prorated and must be paid prior to a child returning. Repeat offenders will be asked to withdraw their child from the centre.

Health Closure Information:

- ❖ If School Districts deem it necessary to close schools due to health concerns, such as COVID-19 it may necessary for TTK to close as well. Please note, it is always our intention to provide child care for families that need it. If this situation were to arise, we will notify families as soon as possible and follow up with further information as it becomes available.
