

September 2026 to July 2027 Spul'u'kwuks Clubhouse Fee Schedule

FULL-TIME RATES:

- **\$563.00** per month for school age full-time care (September/October/November/January/February/March/May/June/July)
- **\$32.00** per day for days school is in session in December 2026 (4 days)
- **\$32.00** per day for days school is in session in April 2027 (2 days)

Monthly fee includes:

- ❖ Early Dismissals
- ❖ Professional Days

Monthly fee does not include:

- ❖ Winter Vacation 2026
- ❖ Spring Vacation 2027

Morning ONLY RATES:

\$314.00 per month for AM care only (7:00am to 8:45am only)

- **\$27.00** per morning for days school is in session in December 2026 (4 days)
- **\$27.00** per morning for days school is in session in April 2027 (2 days)

The monthly fee does not include:

- ❖ Early Dismissals
- ❖ Professional Days
- ❖ Winter Vacation 2026
- ❖ Spring Vacation 2027

Drop-in RATES (if available)

\$63.00 Professional Days

Withdrawal information:

- ❖ **ONE MONTH'S** written notice or **PAYMENT** in lieu of notice is required to withdraw your child from the centre. Notice must be received no later than the 1st of the prior month. Notice for September must be received no later than August 1st or the September fee will be processed.
- ❖ Vacancies which occur after May 1st, are difficult to fill. The fees for June/July will be required if written notice is received after May 1st.
- ❖ To secure a child's space for the coming school year the July payment is required.

Payment information:

- ❖ Families will have the option of paying by pre-authorized debit or credit card.
- ❖ If a child is unable to attend the centre due to illness or holidays families are still responsible for the full payment of agreed fees for the month.
- ❖ Families with fees outstanding for 45 days or more will be asked to withdraw their child until their account is current.
- ❖ All declined payments (Visa/MasterCard/pre-authorized debit) are subject to a \$40.00 fee.
- ❖ All Credit Card payments are subject to a 2.4% service fee.
- ❖ The Affordable Child Care Benefit is a provincial program that helps eligible low-income families with child care costs. Families approved for ACCB are responsible for paying the difference between the approved benefit and TTK's fees. It is the parent or guardian's responsibility to apply for ACCB, keep the benefit active, and pay the full fee if the benefit expires or is delayed. TTK cannot apply on behalf of families, track application status, remind families of expiring benefits, or back-date Child Care Arrangement forms. ACCB approvals received more than three months after attendance, or after December 31 for a previous year, will not be processed.
- ❖ ACCB is submitted at the beginning of each month based on your child's actual attendance from the previous month and is credited to the following month's invoice. As payments are attendance-based, monthly ACCB amounts may vary. Any overpayments from your child's first month of care will be applied to scheduled breaks (Winter, Spring, or Summer) or refunded upon withdrawal.

Late Charges:

- ❖ Our centres close at 6:00 pm daily. Parents/Guardians picking up their child will be charged \$10.00 for every 15-minute block after 6:00 pm. The late fee is not prorated and must be paid prior to a child returning. Repeat offenders will be asked to withdraw their child from the centre.

Health Closure Information:

- ❖ If School Districts deem it necessary to close schools due to health concerns, such as COVID-19 it may necessary for TTK to close as well. Please note, it is always our intention to provide child care for families that need it. If this situation were to arise, we will notify families as soon as possible and follow up with further information as it becomes available.
